REGISTRATION RULES

1.0 GENERAL INSTRUCTIONS

When interpreting this registration form and the Published Rules governing registration, the following **standard terms** shall apply:

The O.S.A.: is The Ontario Soccer Association
Published Rule: is a By-Law, Rule, Regulation, Policy, Procedure, or Law that is adopted by the O.S.A. or any organization under whose jurisdiction the O.S.A. operates.

This Form: is the Player Registration Form provided by the O.S.A.

The Player: is the player named on this form.

The team: is the team indicated on this form.

Any game: is any exhibition, league, tournament, or cup, game **sanctioned** by the O.S.A.

The Club: is named on this form; and is the organization operating the team and which is responsible for registering the player on the team.

Club Registrar: is the person(s) authorized by the club to register the club's players and who is responsible for signing this form prior to submitting it to the District Association for validation

The District Association: is the organization with which the club is affiliated and which is responsible for the validation of this form.

District Registrar: is the person(s) authorized by the District Association to oversee player registration and who is responsible for the validation of this form.

The validation: of this registration form occurs when the District Registrar signs this form and enters the date of authorization in the shaded area on this form.

1.2 The player named on this form is registered **ONLY AFTER** this form has been properly completed, signed by the player, signed by the Club Registrar, validated by the District Registrar, and the registration data is entered into the O.S.A. Registration application by the District Association. It is the responsibility of the club to ensure that the player does not play before the "Effective Date" of his/her registration.

1.3 Registration on this form entitles the player to play for the team against another Registered Team in an exhibition, league, cup, or tournament game, **one day** after the validation of this form by the District Registrar, providing that the game is sanctioned by the O.S.A., and providing that the registration data is entered into the O.S.A. Registration application after validation by the District Registrar.

1.4 As the information on this form will be transferred to a computer, it is imperative that all information is legibly printed or typed. Enter only one character (i.e., letter or number) in each character space provided.

1.5 This form requires the Registration numbers for clubs, leagues, divisions and teams. The Team Registration Number is assigned by your Club and the other numbers can be obtained from your District Association.

2.0 SEASON YEAR

2.1 For outdoor soccer, indicate the year for which the player is registering.

2.2 For indoor soccer, indicate the two years in which the season overlaps (eg. 1997-98, 1998-99).

3.0 PLAYER DETAILS

3.1 Enter the O.S.A. Registrant number. If unknown, your Club can obtain it from its District Association.

3.2 Enter the Ontario Medical Number (optional), the sex of the player, the player's previous last name if his/her last name has changed and the date of birth of the player.

3.3 Enter the first name, middle name and last name of the player.

3.4 Enter the address, postal code, telephone numbers, fax number, E-Mail address and Notes Mail address of the player. If the player lives outside of the province and/or country, put a line through the ON and/or CANADA and write in the appropriate province and/or country.

3.5 The District Registrar must indicate how the "Proof of Birthdate" was checked by putting a **T** in the appropriate box.

3.6 A Player Registration Book (PRB) is required for **ALL** indoor players (except for an indoor player playing in a Club league, or in an Intra-Club Tournament, in which all of the teams are from the same Club) and competitive outdoor players. If the player does not have a PRB, you must obtain one from your District Association before the player's registration can be validated.

3.7 Some outdoor recreational leagues and some Indoor Club Leagues require the player to have a PRB. Please contact your District Association to find out if you require a **PRB**.

3.8 An outdoor youth player cannot exceed the stipulated age before January 1 before the current outdoor season.

An indoor youth player cannot exceed the stipulated age before January 1 during the current indoor season.

An outdoor senior player must exceed the stipulated age before January 1 before the current outdoor season.

An indoor senior player must exceed the stipulated age before January 1 during the current indoor season.

4.0 TEAM DETAILS

4.1 Enter your Club Registration Number and the Name of your Club.

4.2 For the Season Type, check either the "Outdoor" box or the "Indoor" box.

4.3 Indicate the player classification code by putting a **T** in the appropriate box. The legend for the player classification is:

4.4 Enter the name and registration number of your team, league, and division.

5.0 CLUB LAST REGISTERED WITH

5.1 The provision of this information (i.e., club, country, year) is **mandatory**.

5.2 Any person who provides false information or withholds any of the required information shall be suspended from all soccer activities for one year.

6.0 FAILURE TO PROVIDE INFORMATION

6.1 The information required on this form must be provided or the registration will NOT be validated.

6.2 Any person who provides false information or withholds any of the required information shall be suspended from all soccer activities for one year.

7.0 PLAYER'S SIGNATURE

7.1 The player must read the DIRECTIONS on this form, especially 5.1, 5.2, 6.1 and 6.2, prior to signing this form. Each club has been provided with a copy of the Constitution and the Published Rules of the O.S.A.

8.0 OTHER REQUIREMENTS

8.1 A player 14 years of age or over who was last registered in another country, requires an **International Transfer** before registering.

8.2 Any player **under suspension from all soccer activities** may not register.

8.3 A player who was last registered as a non-amateur or professional player, requires a reinstatement to amateur status (either permanent reinstatement or temporary reinstatement for indoor only) prior to registering as an amateur player.

8.4 As it is the Club's responsibility to ensure that each of its players comply with 8.1, 8.2 and 8.3, it shall be disciplined for non-compliance.

9.0 CLUB REGISTRAR'S SIGNATURE

9.1 The Club Registrar must sign and date this form. Signing this form, binds the club to all O.S.A. registration rules regarding the registration of this player, especially 8.4.
